Sub.: - Amendment in the Rajasthan Government Servants' General Provident Fund Rules, 1997.

In exercise of the powers conferred by the proviso to Article 309 of Constitution and Rule 21 of Rajasthan Service Rules, 1951, the Governor hereby makes the following rules further to amend the Rajasthan Government Servants' General Provident Fund Rules, 1997, namely: -

1. These rules may be called the Rajasthan Government Servants' General Provident Fund (Amendment) Rules, 2009.
2. They shall come into force with effect from 01.11.2009.
3. The existing clause (i) of sub-rule (1) of Rule 11 shall be substituted by the following, namely: -
"(i) Monthly deposit depending upon the total of pay in Running Pay Band and Grade Pay thereon of the subscriber at the rates prescribed below: -

| Total of Pay in Running Pay Band and Grade Pay | Rate of Deduction (in rupees) |
|--|-------------------------------|
| Upto Rs.9000/- | 500.00 |
| Rs.9001/- to Rs.11000/- | 650.00 |
| Rs.11001/- to Rs.15000/- | 1100.00 |
| Rs.15001/- to Rs.20000/- | 1450.00 |
| Rs.20001/- to Rs.24000/- | 2100.00 |
| Rs.24001/- to Rs.28000/- | 3300.00 |
| Rs.28001/- to Rs.31000/- | 4100.00 |
| Rs.31001/- to Rs.45000/- | 5200.00 |
| Rs.45001/- to Rs.65000/- | 5700.00 |
| Above Rs.65000/- | 6200.00" |
